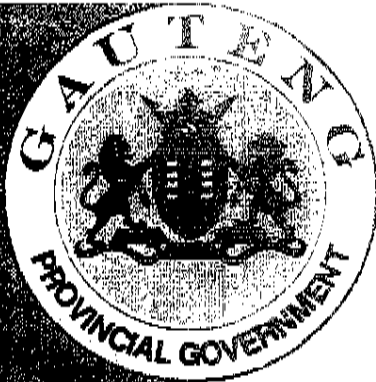

In addition, a letter was sent by this Department as courtesy informing you that the file was due for closure wherein you were granted an opportunity to respond within seven days and indicate to the Department of your applicant's willingness to proceed with the application or request for an extension. To date, no correspondence was received.

In light of the above, you are informed that this file has been closed with immediate effect and if the applicant still wishes to pursue the above mentioned activity then a new application must be submitted in terms of the Environmental Impact Assessment Regulations, 2006, (GN R.385) published under the National Environmental Management Act (NEMA) (Act No. 107 of 1998)(as amended).

The Department would further like to inform you that construction prior to authorisation constitutes contravention of Section 24F (1) of the National Environmental Management Act (Act 107 of 1998) (amended) which states the following: "No person may commence an activity listed in terms of section 24(2)(a) or (b) unless the competent authority has



granted environmental authorisation for the activity, and no person may continue an existing activity listed in terms of section 24(2)(d) if an application for an environmental is refused.
