

PUBLIC NOTICE OF BASIC ASSESSMENT PROCESS

Notice is given of an application for Environmental authorization that was submitted to the Gauteng Department of Agriculture and Rural Development in terms of regulation no. R385 published in the Government Notice no. 28753 of 21 April 2006 of the National Environment Management Act, 1998 (Act No. 107 of 1998) governing Basic Assessment procedures (Notice 1- Governing Notice R386) for the following activity:

Property description: Portion 122 of the farm Olifantsfontein 402 JR

Project description: Establishment of a township comprising of:

- (a) Industrial uses/buildings including offices and showrooms (FSR 0.6, coverage 60 %, Height 3 storeys) as well as
- (b) Shops, commercial uses, Industrial uses/buildings including offices and showrooms (FSR 0.6, coverage 60%, Height 3 storeys)

No. R 386, 21 April 2006	16 (b)	The transformation of undeveloped, vacant or derelict land to - residential, mixed, retail, commercial, industrial or institutional use where such development does not constitute infill and where the total area to be transformed is bigger than 1 hectare
No. R386, 21 April 2006	17	Phased activities where any one phase of the Activity may be below a threshold specified in the schedule but where a combination of the phases, including expansions or extensions, will exceed a specified threshold.
No. 386, 21 April 2006	19	The development of a new facility or the transformation of an existing facility for the conducting of manufacturing processes, warehousing, bottling, packaging, or storage, which, including associated structures or infrastructure, occupies an area of 1 000 square meters or more outside an existing area zoned for industrial purposes.
